School Expectations

 Work for Wednesday 1st February will be available to parents on Monday 30th January in order to prepare for the first day of learning.

Family Expectations (pupil/parent/carers)

- It is the responsibility of families to print/use the resources provided at home. In the event of unforeseen circumstances which make this difficult, please contact the school office to discuss alternative arrangements.
- Where possible, it is beneficial for young people to maintain a regular and familiar routine. We recommend that the 'school day' maintains structure. A minimum of 3 hours of learning per day for KS1 and 4 hours of learning for KS2 is recommended.
- We encourage parents to support their children's work by viewing the work set together and then making appropriate plans to complete the work. This can include finding an appropriate place to work and, to the best of their ability, supporting pupils with work encouraging them to work with good levels of concentration.
- Parents/carers can access a range of other resources and home learning activities available.

The Academy Committee members and Senior Leadership Team at Hinguar Primary School are fully aware that these are exceptional times, and each family is unique. Because of this, we will approach remote learning in a way which suits families with their individual needs. We realise that the circumstances that cause our school to close will affect families in a number of ways. In our planning and expectations, we are aware of the need for flexibility from all sides, in particular parents who may be trying to work from home so access to technology as a family may be limited. Therefore, we can, on request, provide a range of non-digital activities to support families on an individual basis.

Logins to Online Learning Platforms

The school subscribes to a number of online learning resources which can be accessed at home. It is essential that children and parents have access to all the relevant login details from the start of the school year so that they are immediately available in this event of a closure of self-isolation. Printed Resources

We will discuss individual family circumstances should there be extenuating circumstances regarding accessing online materials.

Safeguarding

We must emphasise the importance of a safe online environment and encourage parents and carers to set age-appropriate parental controls on digital devices and use internet filters to block malicious websites. We ask parents/carers to have discussions with their children about the importance of online safety and what to do if anything makes them feel uncomfortable. If they ever wish to report harmful online content, then they should visit: <u>UK Safer Internet Centre</u>. If they wish to get advice on reporting online abuse, they should visit the National Crime Agency's <u>Child Exploitation and Online Protection command</u> or click on the CEOP button on the dedicated Safeguarding page on our website.

It's especially important for parents and carers to be aware of what their children are being asked to do, including:

• sites they will be asked to use

We will continue to emphasise the importance of a safe online environment and encourage parents and carers to set ageappropriate parental controls on digital devices and use internet filters to block malicious websites. These are usually free, but often need to be turned on. Parents/carers can find a range of links to help keep their children safe online here:

Monitoring Engagement with Remote Education

It is important that children engage with the remote education provided so that they don't fall back with their learning, however we do acknowledge that each family's home circumstances are unique and there may be factors that affect engagement with home learning. These may include parents working from home or limited access to technology amongst other factors. Communication is essential and we would ask that if there are circumstances that mean a child cannot engage at least partially with the remote education that their parent speaks to the school. We can then work together to find a means of providing remote education that works for that family's circumstances.
